Dear Mr. Rappaport:

I am writing in response to your letter dated July 13, 2001 regarding the above referenced issue.

In your letter you requested information on accounts listed under the "Wild Ones" tax identification number, current account balances and a transfer of funds into a different account. It is my understanding this request is in connection with a dispute between your organization and the account holder.

Only the authorized signer or owner of an account has the authority to request transactions and obtain account information. Thus, you should contact the account holder directly in order to request information. Any agreement permitting you to obtain information or take other actions is between your group and the account holder and we are not a party to it nor can you look to us to enforce it against our customer. That is an issue properly brought before a court of competent jurisdiction. If you do pursue this in a court proceeding you may forward any Order directed to us to my attention.

Thank you for bringing your concerns to our attention. Our goal is to provide excellent customer service and your feedback is important to us. We appreciate the time you took to express your thoughts and for providing us with the opportunity to respond.

MOTION TO SUSPEND

WHEREAS, Wild Ones Natural Landscapers Ltd (Wild Ones ®) is a charitable organization, organized under Section 501(c)(3) of the Internal Revenue Code of the applicable provisions of the Wisconsin Non-Stock Corporation Act; and

WHEREAS, Wild Ones welcomes, encourages and authorizes the formation of Chapters of the Corporation under Article VII, Section 1 of the By-laws; and

WHEREAS, Chapters are not separate legal entities, there is only a single corporate entity governed by a Board of Directors; and

WHEREAS, Chapters must subscribe to and abide by the Policies as set forth by the Board of Directors per Article VII, Section 1 of the By-laws; and

WHEREAS, Members shall subscribe to and abide by the Policies as set forth by the Board of Directors per Article II, Section 2.b; and

WHEREAS, Michelle Vanstrom has repeatedly acted in direct contradiction to the policies and direction of the Board of Directors, and

WHEREAS, Robert Baxter has continued Michelle Vanstrom's actions when succeeding her as President of the Niagara Chapter of Wild Ones by refusing to act and contradicting the policies and directions of the Board of Directors,

NOW, THEREFORE, in accordance with the applicable provisions of the By-Laws, I hereby move as follows:

That Michelle Vanstrom and Robert Baxter be suspended for an indeterminate period of time as members of Wild Ones per Article II, Section 2.c, failure to abide by the Policies as set forth by the Board of Directors; and

That Michelle Vanstrom be removed from the Board of Directors under Article IV, Section 10 for actions unbecoming a Director and under Article IV, Section 2, only members may serve as a Director.
